

## New York / New Jersey 2nd Annual Gratitude Dinner

## Getting Clever Feet

These tools in the FAA Literature start to build this relationship with a Power greater than me! That is one aspect of this recovery business that really moves me - the simple act of putting down the extra bite of vegetables, the extra piece of food is such an incredible simple way of surrendering again, and inviting my Higher Power in, yet at times it can be so hard to do. I guess that's where the combination of Will and Surrender comes in.

I know that the correct use of my Will is to firmly aim myself towards the food plan, and the other FAA tools. I have this repetitive thought that is starting to become louder, which says 'you still have a choice' just as I am reaching for an extra bite/ or walking into a shop I know I've picked up sugar in (these days I try to avoid a particular deli that I often picked up in)... if I find one part of my mind has begun explaining to me why its' a good idea to go to that particular shop, or just have one more tiny bit of a vegetable, the thought pops in... 'you still have a choice' and then the saying I hear at meetings comes to mind 'get clever feet' - these are the kind of feet that walk me away from dangerous places/shops/behaviors, so even whilst the addict part of my mind is saying 'yes but what about eating this or going there' my feet are quietly walking me in another more loving direction.

Thank God for the ongoing development of 'clever feet' and the kindness and generosity of other people in FAA sharing their experience.

#### **Minutes – FAA Board of Trustees**

#### **January 20, 2013**

Open with Serenity Prayer at 8:00 EST

Roll Call: All Board Members, Parliamentarian and Executive Assistant are present. Three visitors identified themselves.

Co-Moderator gave a brief explanation of Board Meeting expectations. **COMMITTEE REPORTS:** 

Co moderator: No report

Treasurer Report: Treasurer sent report to the Board for review. Received and documented the 2012 Convention overages of \$17,065.73. Donations were steady and literature sales were up. Credit card processing and telephone charges were over budget again. Payroll was over for this month but will level out next month. Phyllis commented that \$56,000 is in the money market account.

Convention Committee: At the time of this meeting there is no Chair for the Committee. Discussion on how to proceed as the By-laws state that Committee must have a Board member as Chair and the Chair gives the report. Group decided to have Co-Chair Patty give the Convention report as follows: The Committee is working on finalizing contract. Patty has been to hotel and has also looked at transportation issues. Registration is getting ready except for logo. Finalizing the budget. Next Meeting is 1/21/13. February 1, 2013 is goal date for on line registration. After the report was given, Jewell Elizabeth stepped up to be new Chair of convention committee. All approved.

Office Committee: 250 Green Books came in with a bad green color. Ordering new samples to get a better green. The office continues to work on the lawsuit from the 2009 convention. Need a co-editor for the abstinent times. The gold foil is no longer available for use on our chips and to switch vendors would require us to pay set up fees again. Committee voted to go with black foil since it is most cost effective. The new phone number will go in to effect on February 1, 2013. The new phone number is 772-878-9657 and Fax 772-878-9658. The old number will continue to work for 6 months. 2 applicants for webmaster job have been found. Office Committee will have a technical conference call with candidates and Kevin and Patty. Need to check on 3 bid for expenses over 1,000 dollars.

Literature Committee: Finalized the search for a 3rd step prayer. January 30th is the next meeting. Update on editing of translating Spanish packet. The original request was by a few Latino members about 6 years ago.

Ad Hoc Web Committee: Next Meeting is Feb 11 7:30 est. Group is editing phone meeting page to look more like the face to face meeting page.

Waiting on quotes. Ohio convention bought additional insurance for the convention and price was very reasonable. Guest questions: Can we use Ohio insurance contact.

Tuesday will have the webmaster conference call with Kevin and applicants. We need an editor for Abstinent Times. CA Lawsuit update: our attorney has not heard back from their attorney. EA described the editor position will be to obtain articles, help with format, and possibly revamp the newsletter overall. We need someone to take initiative for overall AT production. EA reported subscription is total 90-110 and we have to print 150. Some are also sold individually on the Internet. Some are also sold as PDF's. All meeting contacts and board members get a free copy. Literature Committee: Jewell Elizabeth gave report. The current issue is the copyright issues concerning " I Express My Emotions Directly". They did not discuss any other issues at last meeting. Discussion started with what book was it found in and did anyone investigate getting permission to use for FAA to adapt it. Response was committee was not looking into getting permission. The committee decided to write a new one and not get permission to use the old one. ## Ask Abstinent Annie

Dear Abstinent Annie:

My sponsor recently told me to avoid the BLT's, the bites, licks and tastes when preparing food. This sounded kinda extreme to me, what are your views?

**Bewildered Betty** 

Dear Betty:

Great question! Let me just say from my own experience, that BLT's lead to trouble. Probably the voice of your disease is saying, "Come on, we don't have to be fanatics!.....what's one little bite?" In my case, one extra bite led to a binge. At the time, the voice of my disease assured me it was going to just be one bite....wrong!

As a food addict, I have to be vigilant around food, even the smallest amount can open the door to addictive eating for me. That is why we weigh and measure, because that structure works. When I am preparing or handling food, I wash my hands immediately, so that I won't accidentally or consciously put any extra food in my mouth.

Many people have shared that their relapse began very gradually with extra food. Guard your abstinence, it is so precious.
